HANDLER - CLIENT CONTRACT 2012

This contract will be legal and binding for the entire time the dog is in the handler's possession and thereafter.

PURPOSE OF AGREEMENT. The purpose of the agreement is to state the duties and obligations of Handler and Owner or Responsible Person, respectively, concerning the placing of the below-described dog with Handler to be shown at dog shows licensed, sanctioned, or recognized by the American Kennel Club or any other kennel club, or at any specialty show, match, or any other activity which Owner or Responsible Person may designate.

AS AGENTS OF YOUR DOG(S) WE AGREE TO:

1. ENSURE THAT THE WELL BEING, SECURITY, AND COMFORT OF THE DOG(S) IN OUR CARE IS PLACED ABOVE ALL OTHER CONSIDERATIONS. THEY ARE OUR FIRST CONCERN WHILE AT OUR HOME AND ON THE ROAD, AS WELL AS AT THE DOG SHOWS.
2. PREPARE AND PRESENT YOUR DOG(S) TO THE BEST OF OUR ABILITY AND CONDUCT OURSELVES IN A PROFESSIONAL AND SPORTSMANLIKE MANNER AT ALL TIMES TO ALL PEOPLE.
3. PROVIDE AN ITEMIZED MONTHLY STATEMENT FOR ALL SERVICES AND PRODUCTS.
4. PROVIDE YOU WITH ALL OF YOUR RIBBONS, TROPHIES AND INFORMATION ABOUT YOUR DOG'S PLACEMENTS IN A TIMELY MANNER. ALL MONETARY AWARDS SHALL BE RETAINED THE HANDLER.
5. HAVE AN UNDERSTANDING OF THE BREEDS AND THEIR STANDARDS OF ANY BREED WE SHOW. WE REPRESENT YOU AND YOUR BREED AS WELL AS THE SPORT OF DOGS.
6. KEEP OUR CLIENT/HANDLER RELATIONSHIP HONEST, ETHICAL AND CLEAR.
7. KEEP YOU INFORMED OF OUR SCHEDULE PLANS AND DISCUSS ALL UP COMING SHOWS BEFORE ENTERING YOUR DOG(S).
8. PROVIDE YOU WITH AN UP TO DATE RATE CARD WHEN REQUESTED.
9. REPRESENT YOUR, YOUR DOG AND YOUR BREEDING IN A POSITIVE PROFESSIONAL WAY.
10. NEVER SHOW AGAINST YOUR CLASS DOG OR BITCH WITH ANY OTHER CLASS DOG OR BITCH OF THE SAME SEX AND BREED, AND NEVER SHOW TWO SPECIALS OF THE SAME BREED AT THE SAME TIME, REGARDLESS OF SEX. THE ONLY EXCEPTION TO THIS WOULD BE BY OWNER REQUEST AND ONLY IF BOTH DOGS ARE OWNED BY THE SAME CLIENT.
11. IN THE EVENT THAT THE HANDLER CANNOT SHOW THE DOG, ANOTHER COMPETENT HANDLER OF THE HANDLER'S CHOOSING WILL REPLACE THE HANDLER IF AT ALL POSSIBLE. ALL REGULAR FEES WILL APPLY.
12. THAT ALL DOGS WILL RECEIVE EQUAL TREATMENT TO THE BEST OF OUR ABILITY, BUT IN THE CASE OF A SCHEDULING CONFLICT, PRIORITY WILL BE ASSIGNED ON THE BASIS OF LENGTH OF CONTRACT RELATIONSHIP AND STATUS OF THE DOG IN ACHIEVING A SET GOAL. IN ALL CASES, THE HANDLERS JUDGEMENT REGARDING WHICH DOG TAKES PRIORITY IS THE FINAL DECISION.

OUR CLIENT AGREES TO:

1. PAY ALL BILLS IN A TIMELY MANNER.
2. USE OUR AGENT NUMBER ON ALL ENTRIES WHEN WE ARE TO HANDLE YOUR DOG(S). ODEBT: 0550 / RAU - R-1097, BILL 0549.
3. BE RESPONSIBLE FOR ALL ENTRY FEES, SHOW PHOTOS, REGULAR PERSONAL DOG EXPENSES AND VETERINARY EXPENSES INCURRED BY OR FOR YOUR DOG(S).
4. BE RESPONSIBLE FOR A CHARGE OF 50% OF ALL FEES, ONCE HAVING COMMITTED YOUR DOG(S) TO A SHOW OR CIRCUIT OF SHOWS IF YOUR DOG(S) DO NOT GO, FOR ANY REASON, UNLESS THE COMMITMENT IS WITHDRAWN 5 DAYS BEFORE THE CLOSING OF SAID SHOW(S) OR 5 DAYS BEFORE THE CLOSING OF THE FIRST SHOW OF A CIRCUIT. THE COMMITMENT MUST BE WITHDRAWN IN WRITING.
5. KEEP YOUR DOG(S) UP TO DATE ON ALL VACCINATIONS, INCLUDING RABIES, DAPP-CV AND BORDATELLA IS RECOMMENDED.
6. NEVER SEND A DOG TO OR WITH US KNOWING IT IS CARRYING OR HAS BEEN EXPOSED TO ANY CONTAGIOUS ILLNESS.
7. GIVE US COMPLETE AUTHORITY TO HAVE YOUR DOG(S) TREATED BY A LICENSED VETERINARIAN FOR ANY ILLNESS, INJURY, ACCIDENT OR EMERGENCY, AND BE RESPONSIBLE FOR ANY CHARGES INCURRED BY YOUR DOG(S) BY THE SIGNING OF THIS CONTRACT. YOU MUST PROVIDE US WITH A CREDIT CARD OR PAYMENT METHOD IN THE CASE OF ANY VETERINARY EMERGENCY CHARGES.
8. KEEP THE CLIENT/HANDLER RELATIONSHIP HONEST, ETHICAL AND CLEAR.
9. BRING ANY AND ALL QUESTIONS, COMPLAINTS OR PROBLEMS, ABOUT OR WITH US, DIRECTLY TO US AND UNDERSTAND WE WILL DO THE SAME FOR YOU.
10. INFORM US OF ANY FEED BACK, POSITIVE OR NEGATIVE FROM ANY EXHIBITORS, SPECTATORS, FRIENDS OR OTHERS. THIS IS TO HELP US IMPROVE OUR SERVICES TO THE BEST OF OUR ABILITY.
11. KEEP APPROPRIATE WIN AND AKC RECORDS.
12. GIVE US ANY MICRO CHIP OR IDENTIFICATION NUMBERS FOR THE DOG FOR OUR RECORDS.
13. ACKNOWLEDGE THAT THE INDIVIDUAL DOG IS NOT INSURED BY THE HANDLER AGAINST LOSS AND THAT ANY LOSS IS THE RESPONSIBILITY OF THE OWNER(S) UNLESS NEGLIGENCE IS PROVEN. _____ Initial.
14. THE CLIENT UNDERSTANDS IN ADDITION, IF THE DOG COMES TO US NEEDING ONLY IT'S MAJORS AND WE HAVE NOT SHOWN SAID DOG PRIOR, \$100.00 PER POINT WILL BE ADDED TO OUR NORMAL FEES AND EXPENSES. _____Initial

WE REQUIRE :

1. A MINIMUM DEPOSIT OF \$500.00 AT THE TIME WE TAKE YOUR DOG(S) TO SHOW.
(\$800.00 minimum for a circuit of two or more weekends or for dogs that will live with us during their career). The deposit does not include money for entry fees or other expenses, this deposit is applied to handling costs, mileage and board.
2. VIEWING AND EVALUATION OF YOUR DOG BEFORE AGREEING TO SHOW IT.
3. A \$300.00 DEPOSIT JUST FOR ENTRIES, IF YOU ARE TO HAVE US MAKE YOUR DOG(S) ENTRIES, OR A CREDIT CARD AND THE REQUIRED INFORMATION SPECIFICALLY FOR THE PURPOSE OF MAKING YOUR DOG'S ENTRIES ONLY. THIS IS HIGHLY RECOMMENDED FOR SPECIALS DOGS.
4. THAT THE DOG(S) COME TO US AT LEAST 24 AND PREFERABLY 48 HOURS BEFORE ANY SHOW, UNLESS WE HAVE PREVIOUSLY AGREED TO RING SIDE/GROOMING SETUP PICK UP. SOME BREEDS REQUIRE A LONGER PERIOD BEFORE A SHOW TO BOND WITH US AND BE ABLE TO WORK WITH US. THE BEST RESULTS GENERALLY COME FROM A DOG LIVING WITH US DURING THE DURATION OF THEIR SHOW CAREER.
5. PROOF OF RABIES VACCINE, TO CARRY WITH US (PHOTO COPY IS OKAY).
6. PAYMENT OF A MINIMUM OF 50% ON EVERY MONTHLY STATEMENT unless A PAYMENT PLAN HAS BEEN AGREED UPON.
7. THAT YOU KEEP THE ENTRY FEE MONEY WITH A CREDIT BALANCE OF NO LESS THAN \$100.00 AT ANY TIME DURING THE SHOW CAREER. WHEN WE ARE NO LONGER SHOWING YOUR DOG(S) ANY ENTRY MONEY LEFT WILL BE CREDITED TO YOUR HANDLING BALANCE.
8. THAT ONCE YOU HAVE COMMITTED YOUR DOG(S) TO A SHOW OR CIRCUIT IF SHOWS IN THE CASE THAT YOUR DOG DOES NOT GO TO THE SHOWS, YOU WILL BE RESPONSIBLE FOR A CHARGE OF 50% OF ALL FEES FOR YOUR DOG(S), UNLESS YOU HAVE WITHDRAWN YOUR COMMITMENT, IN WRITING, WITHIN 5 DAYS BEFORE CLOSING OF THE SHOW OR THE FIRST SHOW OF A CIRCUIT, REGARDLESS OF THE REASON.
9. WHEN MAKING ENTRIES FOR YOUR DOG WHEN ARE WE CONTRACTED TO SHOW IT YOU WILL USE OUR AGENT NUMBER(S) ON ALL ENTRY FORMS AND/ INCLUDE OUR NAME AS AGENT ON ALL ENTRY FORMS. ODEBTS AGENT NUMBER IS 0550 FOR ALL SUPERINTENDENTS EXCEPT RAU AND THAT NUMBER IS R-1097. BILLS AGENT NUMBER IS 0549.

THE TERMS OF THIS CONTRACT ARE AGREED UPON BY THE PERSONS SIGNING BELOW. THE TERMS INCLUDE PERMISSION TO HAVE ANY DOG(S) OWNED BY THE CLIENT TREATED BY A LICENSED VETERINARIAN, IN THE EVENT OF ILLNESS, INJURY, ACCIDENT OR EMERGENCY, AT THE DISCRETION OF THE HANDLERS AND THE CLIENT WILL BE RESPONSIBLE FOR ALL EXPENSES INCURRED BY THEIR DOG(S). All amounts due under this contract, including damages for it's breach, shall be paid in El Paso County, Colorado, and any suit brought on this contract shall be brought in El Paso County, Colorado only.

Under no circumstances will Odebt Massey or Bill Massey or any of their assistants to be held liable for any damage which may arise from or be a direct result of the boarding, handling, or transporting of client dog(s), including but not limited to loss by fire, theft, escape, death, injury to person or dogs. It is understood that we exercise all due and responsible care and precautions to prevent any injury, illness, or loss of a client's dog while traveling, at home and at the show site, however The Owner agrees to hold Odebt Massey and/or Bill Massey harmless for any accidental injury and/or loss of the dog incurred during the normal function of boarding, traveling, grooming or handling.

Any changes or alteration to this agreement must be made in writing. No other promises, conditions or provisions are implied, unless attached to this contract.

Mileage rates are \$.40 per mile, round trip. Handling rates are \$60.00 to \$95.00, per dog, per show.

Board fees are from \$6.00 to \$15.00 per night, per dog, plus actual costs of dog food and supplements for your dog only. These are our flat rates, no surprise charges will show up on your bills. We do not charge bonuses but we do of course accept them. Any other charges incurred by your dog, for your dog, such as veterinary, entry fees, photos and other charges that are separate from our handling, mileage and board fees are at actual cost and will be discussed prior to incurring them except in an emergency.

Charges for mileage are for all dogs contracted to be handled by us at any dog show regardless of who transports them to the shows unless it is agreed upon for ringside pick-up only and we have no other responsibility for the care of the dog nor the grooming of the dog nor the training of the dog. Ring side pick up handling charges are \$10.00 higher than contract rates. Grooming rates on non contract dogs are by individual quote.

Inquire about specific rates for your dog. Email or call for quickest information.

IT IS RECOMMENDED THAT EACH DOG BE SHOWN FOR AT LEAST 5 SHOWS TO DETERMINE IT'S POTENTIAL AND ABILITY TO COMPLETE THE GOALS OF THE HANDLER AND OWNER(S).
